

## “Limited Offer 999PLN/BED”

### Terms & Conditions

#### Clause 1 General Provisions

1. These Terms & Conditions (“Terms & Conditions”) set out the terms and conditions of the promotional campaign carried out under the name “Limited Offer 999PLN/BED” which consists in reducing the regular bed price from PLN 1,350 to PLN 999 per month for a period of 24 months (hereinafter referred to as “the Promotion”).
1. The Promotion is organized by SH GGH Management 8 Sp. z o.o. Sp. K. with its registered office in Warsaw, address: ul. Emilii Plater 53, 00-133 Warszawa, entered in the Register of Businesses kept by the District Court for the capital city of Warsaw in Warsaw, 12th Commercial Division of the National Court Register, under number KRS 0000572571, NIP (Tax ID No.) 5223036641, REGON (Statistical ID No.): 362345709 (hereinafter referred to as “the Organizer”).

3. The “Limited offer 999 PLN/BED” Promotion is not combined with other promotional or special offers (including discounts).
4. Promotion graphics are displayed on [www.livinnxpoland.pl](http://www.livinnxpoland.pl) website, on the LivinnX profile on Facebook and on the LivinnX profile on Instagram.

#### Clause 2 Duration of Promotion

1. The “Limited offer 999 PLN/BED” Promotion is valid between 10 July 2019 and 31 October 2019 or while stocks last.
2. The Organizer may extend the duration of the Promotion by providing graphics on [www.livinnxpoland.pl](http://www.livinnxpoland.pl), on the LivinnX profile on Facebook or on the LivinnX profile on Instagram.

#### Clause 3 Promotion Rules

2. Any individual aged between 18 and 26 with full capacity for legal transactions, who currently is or will be a university student as of 1 October 2019 and meets the conditions set out in these Terms & Conditions, is eligible to participate in the Promotion (hereinafter referred to as “the Promotion Participant”)
3. The Promotion consists in renting one bed for a period of 12 months in a double unit equipped with “share studio” loft beds for the price of PLN 999 per month.
4. To take advantage of the Promotion, you must book a bed in a double unit equipped with “share studio” loft beds:
  - a. via [livinnxpoland.pl](http://livinnxpoland.pl) website, and also
  - b. at the office of the Promotion Organizer, LivinnX, ul. Romanowicza 4 in Kraków.
5. So long as the Promotion is valid, the Promotion Participant may participate in the Promotion more than once subject to compliance with the conditions specified in these Terms & Conditions, but until such time as there are no longer any available units covered by the Promotion.

7. The provisions of these Terms & Conditions do not violate or impair the customers' rights under the implied warranty.

#### **Clause 4 Final Provisions**

1. These Terms & Conditions take effect as of 10 July 2019 and will remain in effect throughout the Promotion.
2. The Participant is required to read the Terms & Conditions.
3. By participating in the Promotion, you agree to and accept the provisions of these Terms & Conditions.
4. Matters not covered by the Terms & Conditions are governed by the provisions of the Civil Code and other legislation.
5. All disputes between the Promotion Organizer and participating renters will be settled by the competent common court.
